## Physicians, administrators focus on quality care amid changes

The roadmap has been laid for implementing sweeping health care reform, and local physicians and administrators are preparing for what it will bring.

An increase in patients who previously did not have insurance is at the center of most of their concerns. Slow or troublesome Medicaid reimbursements continue to be a thorny issue for many health care professionals, who are concerned an influx of new patients will only complicate financial matters.

Others are worried an increasing shortage

### **Industry Q&A**

New Orleans CityBusiness interviewed 10 health care specialists about the state of the medical industry and how they are coping with the recovery and changes it's bringing to the health care industry. They were asked the following questions:

- What's the No. 1 concern within your specialty in the New Orleans area?
- What will be the biggest impact of the new health care legislation on the local level?
- What has been the biggest improvement in regional health care during the past year?

of physicians and a trend of fewer medical school graduates will not only stretch those in the profession thin but make access to care even more difficult.

The rising cost of care is considered another obstacle, but a fear of the unknown tops the list of industry concerns. Even though many practitioners speculate there will be good and bad outcomes from the health care legislation, most say there's no way to really know what will happen in 2014 when the majority of the changes take effect.

But most health care professionals agree on one thing: they plan on working through all the language — and challenges — to provide quality care for the area's patients.

New Orleans historically has trailed many comparable-sized cities throughout the nation when it comes to health care, but technological advances and new medical procedures during the past several years have helped the area's health care professionals tackle longstanding regional problems.

Three hospitals on the North Shore have joined together to find solutions to that area's health care problems, showing that professionals are willing to move past competition for the greater good of the general population.

Three major construction projects, and one on the horizon, will continue the evolution of the region's medical infrastructure.

The new Veterans Affairs health care facility in Mid-City is expected to begin construction within the next few months, while the Louisiana Cancer Research Consortium and the New Orleans BioInnovation Center are scheduled to open later this year. The latter two projects, in addition to the proposed biomedical district, are expected to make the New Orleans area a go-to destination for health care professionals and researchers.

Construction is also expected to begin on the new University Medical Center before the end of this year. The VA hospital and University Medical Center projects are expected to open by 2014 and 2015, respectively.

Health care in the New Orleans area continues to sit at a crossroads. Only time will tell if the framework being laid now will become the regional medical hub officials envision.•

# Administration

#### **Bob Hawley**

president and CEO, Slidell Memorial Hospital

#### No. 1 concern:

One, there is a significant discrepancy with rates paid at different hospitals and the justifications given to us by the Department of Medicaid. The second concern is the state has to pay back \$239.5 million to the federal government for overpayments paid to the state's hospital system and the way that works is hospitals like Slidell Memorial are paying that back rather than the state hospitals. Lastly, we think the governor should support a provider assessment, which would not increase taxes but bring down significant federal matching money that could be distributed to help alleviate the Medicaid and budget shortfall.

#### Health care legislation:

The legislation will raise the eligibly level to 133 percent of the federal poverty level, which will make more people eligible. We already have a Medicaid problem in the state, which is severely under funded and the state continues to use it as a way to balance the budget. So pushing more people to Medicaid doesn't sound like a pretty picture to me.

#### **Biggest improvement:**

The continuing focus on quality initiatives that has been driven by the federal government and the core measure sets that have been created. Hospitals should compete on price. Quality competition has raised the bar for everybody and that has been good for the consumer.

# Cardiology

#### Dr. Richard Milani

**Ochsner Health System** 

#### No. 1 concern:

My greatest concern is the problem we are having with nutrition and children. This is the breeding ground for cardiac disease. It's a big problem locally and nationally, but if you compare states, certainly we are among the worst. The parallel is the national campaign that took people years and years to stop smoking. It didn't happen in a day.

#### Health care legislation:

You want to get everyone covered and Louisiana has a very high proportion of people who are not covered under regular insurance and are left out of Medicare and Medicaid. I think it will have a big impact on the state and they will have a lot of people that will fall under the new coverage.

#### **Biggest improvement:**

We are one of two centers in the state that has positron emission tomography, or PET, which



can offer stress imaging. It's a very specific means of evaluating heart problems, and there

are very few centers nationwide that offer the technology. That just occurred last year.

# Infectious Diseases

Diseases caused by a virus or bacteria that can be spread from one living thing to another such as HIV, meningitis, malaria, strep throat and influenza

#### Kelo McKay

Lakeview Regional Medical Center

#### No. 1 concern:

The emergence of multidrug resistant organisms, "super bugs," that become resistant to antibiotics. One of the challenges we have is people who have a cold or a virus sometimes are put on an abundance of antibiotics, which creates these bugs that become resistant. We and other facilities are starting programs to put patients on the correct antibiotics to avoid creating these resistant bacteria.

#### Health care legislation:

I think with the fear, there have been some budget cuts in our area with Medicaid, which are hurting all facilities. We really don't know how the health care law will look or affect us because we haven't seen some of those changes.

#### **Biggest improvement:**

I'm finding more collaboration among agencies



and facilities. One thing that has really helped us is we have a community group that gets together and we don't look at boundaries. St. Tammany Hospital, Slidell Memorial Hospital and North Oaks, all of us talk about the issues we have and tackle them together. Then, we implement it throughout all of our facilities so we can have a better outcome for our patients.

# Internal Medicine

The diagnosis and nonsurgical treatment of diseases in adults, especially of internal organs

#### **Dr. Alan Bowers**

strategic outreach director, West Jefferson Medical Center

#### No. 1 concern:

The constraints placed on me as a physician as far as how I want to treat my patients. Oftentimes, we are given a list of medicines we can pick from, we are given permission for tests we can or can't do and we are mandated on how long a patient can stay in the hospital. It takes the power from the physician to treat the patient how he or she sees fit. I think that's the biggest threat to the practice of medicine today.

#### Health care legislation:

We are going to have 40 million people who didn't have insurance who now have insurance and will need physicians to take care of them. In four years we are not going to have enough physicians who have gone through medical school and resident training to deal with that sudden increase. We are going to have to get the

physician assistants and nurse practitioners to handle the onslaught because they won't have access to a doctor as easily as they do now.

#### **Biggest improvement:**

We have a lot of really good specialists in the area and it surprises me, because after the

hurricane so many physicians of all specialties left New Orleans and went to areas where it wasn't going to be so hard. The people who stayed here were almost like pioneers who resettled the area and provided medical care. We have really held together a network of subspecialties.

# Neurosurgery

The study of the nervous system and disorders affecting it


## **Dr. Roger Kelley** Tulane University Hospital and Clinic

#### No. 1 concern:

Reaching out to the community for special neurological interventions. There's a lot we could be doing to prevent stroke and dementia if people took better care of themselves. The question is how do we get the message out there. I think we would make great inroads not just with general health but also with neurological health.

#### Health care legislation:

I believe it has the potential to be very helpful if it translates into more helpful preventive medicine. Basically, if people are given a greater incentive to take better care of themselves and are rewarded financially for doing that, then I think it could be very good for raising the level of quality health care. But, if people use it more as a safety net, where they use the emergency more as their walk-in clinic and take advantage of the system, it could just cause the cost to balloon.



#### **Biggest improvement:**

The further development of stem cell therapy and gene. These are things we certainly want to continue promoting. We are trying to recruit a major stem cell researcher at the neurological realm, but that would be to repair damage that already has taken place and help improve patients who already have Alzheimer's disease, Lou Gehrig's Disease or have suffered a stroke.

# Nursing

#### **Kerry Milton**

senior vice president and chief nursing officer, St. Tammany Parish Hospital

#### No. 1 concern:

With all the changes in health care reform, making sure the focus stays on taking care of patients and helping our staff and physicians accomplish that. We need to make sure nurses have what they need to provide the quality health care we are talking about, whether that's training, equipment or support from management. Nurses need to feel empowered to have a voice and know they have the freedom to communicate. We as leaders and managers have to be mindful of what that goal is.

#### Health care legislation:

At the end of the day all of that

jargon boils down to making sure we can take care of patients and their loved ones and that they are comfortable knowing they will receive high quality health care. I think we need to understand the jargon and the terminology and work through that.

#### **Biggest improvement:**

Health care providers in our region working together on issues of common concern. For example, the North Shore hospitals have joined together to form the North Shore Health Care Alliance, which has been there to help improve and train our health care work force.



# Oncology

#### **Dr. Sean Collins**

oncology committee vice chairman, East Jefferson General Hospital

#### No. 1 concern:

We are doing a very good job of reaching patients in the greater New Orleans area, but I think we can do a better job of reaching patients in the outlying areas. I think screening and education programs particularly focused on the areas outside of New Orleans, where the most need is, would be useful.

#### Health care legislation:

The impact is quite uncertain. There's going to be much more focus on outcome and quantification of outcomes. For example, people would want to measure the quality of a surgery through parameters such as length of stay, complications rates and blood loss, and readmission rates. I think you will see that not just in surgery but also throughout medicine. The idea is to increase the quality and decrease the cost of care. The study of tumors



#### **Biggest improvement:**

Our affiliation with MD Anderson in addition to a number of other expansions we've made in our cancer treatment area such as newer image-guided radiation therapy devices and robotic surgical systems. In my field, at least with prostate cancer, that has allowed us to bring the level of cancer care up to or beyond what patients what would receive anywhere in the country.

# Pediatrics

The study of medicine dealing with the development, care and diseases of children

#### **Dr. Ken Paris** *Children's Hospital*

#### No. 1 concern:

I'm a pediatric allergy and immunology and the biggest concern is higher-than-normal rates of allergy and asthma in New Orleans because of the diverse population as well as the climate of the Gulf South. There's been a continued problem of getting affected patients in the clinic for proper treatment, especially children. It's mostly an access to care issue. The diversity of the problems and the population make it difficult to treat everyone.

#### Health care legislation:

Many more people will have access to care than ever before. How that's going to affect physicians, hospitals and especially the medical education system isn't really known. It's going to be such a huge sweeping overhaul that changing one aspect of health care will have unforeseen ramifications on other aspects. A change in reimbursement or access to care is going to affect other areas more than can we imagine.

#### **Biggest improvement:**

It's been quite a polarizing issue, (the new University Medical Center), but I think it will have the biggest impact on health care in New Orleans. We've started seeing progress downtown, although it's not all tangible. We need to look at it for all the benefits it can bring to the city and the health care system. At Children's Hospital, we recently purchased a helicopter for 24/7 transportation for critically injured kids within the region and the state.

# Pulmonology

**Dr. Ben deBoisblanc** Louisiana State University Interim Public Hospital

#### No. 1 concern:

Probably 80 percent of my practice is critical medicine. We deal with way too much end-of-life care within the ICU. That is, a patient ends up in the ICU who has medical conditions that have played out over decades and we are trying to put plugs in a leaking dike. There is too little emphasis on disease prevention. Up until this point we have taken everyone and no longer should we do this from an ethical point of view, nor can we afford to do that from a fiscal point of view. So we are going to have to find better ways to provide palliative care at the end of life.

#### Health care legislation:

We have a huge uninsured and underinsured population, and many people will have access who didn't have it before. It's projected the Medicaid rolls will expand significantly. On one hand that's a huge plus, because there is a huge number of patients with medical illnesses that, if treated, could prevent hospitalization. But you can't insure more patients without it costing more money. Something has to give.

#### **Biggest improvement:**

Two things have happened. One is the promise of the new health care corridor in the Central Business District, which will bring in the smartest people and technology and a lot of the cost-effective disease management we haven't had before. Now, it's the development of medical home and hospice services and the expansion of primary care services available in the community.

# Radiology

A branch of medicine concerned with the use of radiant energy, including X-rays, in the diagnosis and treatment of disease

#### **Cullen Myers**

vice president of diagnostics, North Oaks Medical Center

#### No. 1 concern:

A decrease in imaging utilization. It's hard to determine whether that is driven by the economy or because there's not enough physicians in the area. We had double-digit growth over the past 15 years because of changes in technology, but it's starting to level off and that's partly because of the health care reform and people not really understanding how this is going to be.

#### Health care legislation:

I think some hospitals are going to have difficulty staying open because of the Medicare cuts and things like that. It's just so early in the game it's hard to judge what's going to happen and not everyone has a full understanding of what the possible impact is going to be.



#### **Biggest improvement:**

The improvements in medical offerings and some of the reduction in diagnostic testing is because of new medicine that is coming out to treat the heart as opposed to requiring imaging intervention. We anticipate more growth, though, because of increased neuroscience processes in the areas of epilepsy and stroke protocols.

# Vascular Surgery

A subspecialty of general surgery in which diseases of the vascular system, arteries and veins are managed largely via surgical intervention

### Dr. Eugene Kukuy

Touro Infirmary

#### No. 1 concern:

One is keeping fresh young surgeons interested in this area. There's a relatively small group of people who do what I do in the city — about a dozen people if not less — and most of the people are aging. The second is keeping the hospitals that do cardiovascular and thoracic surgery busy enough so all these surgeons are satisfied and attract new well-trained surgeons.

#### Health care legislation:

The medical practice is moving toward institutional health care. The issue with paying for the type of health care they propose is Medicaid underpayment. If you put a lot of burden on the states that cannot afford to pay for all of the uninsured, you are essentially going to decrease the amount of reimbursement the hospitals are going to see. My feeling is we won't be able to pay for it, so we will be paid less for more people and the hospitals will go bankrupt.

#### **Biggest improvement:**

To some degree, this institutionalization of physicians has been very positive, at least for our specialty. The fact that we are backed by hospitals and employed by hospitals, it allows physicians to focus on providing medical care more and focus on running a business less. It allows them to practice in the best way.




